Entry Fee : For State & Boards Rs. 1000/- (payable to IABF only)

Weight Class : As per IABF rules, a maximum number of 18 boxers will be permitted.No reserves are allowed.
All Boxers must have their Original birth Certificates
Entry will be accepted on receipt of names (both boxers & of letter head of the affiliated Unit duly signed by the President/

Competition Format : 3 rounds of 2 minutes, 1 minute rest between rounds.

Team Participation : The Participating team may bring 1 Coach, 1 Manager & 1 R/J (2/3 Star/AIBA).

Medical & Weigh-in : General weigh-in and medical examination of all boxers will be held at the venue from 0800-10.00 hrs. on May 27, 2012 and on subsequent days for those boxers who are drawn to Box.

Draw : Draw will be held immediately on completion of the medical & weigh-in on May 27, 2012.

Boarding/Lodging : Free lodging will be provided to all boxers and team officials by the organisers from 26th May to 1st June, 2012.

Arrival particulars : The organisers will have their reception booth at Kolkata Railway Station / Bus Stand. All teams will duly be received on arrival at Coimbatore upon receipt of prior intimation from the units to The Organizing Secretary only.

Conveyance : Local conveyance from Railway Station to their place of lodging and back will be provided by organisers. Transportation will be available for participants & officials to and from venue.

Medals & Certificate : Gold, Silver & 2 Bronze Medals will be awarded along with Diplomas in each weight category.

Important

1. Team officials, boxers and Ring officials are entitled to Railway Concession Orders which are enclosed.
2. The team/officials shall not arrive at venue earlier than the May 26 and shall leave by 1st June, 2012.
3. Cost of travel of all participants and team officials up to Kolkata will be borne by the respective units.
4. 2/3 Star or AIBA Ring officials representing affiliated units must bring a letter of authority from their respective President/Secretary intimating that they have been nominated as Ring Official.
5. In case of extra member in a team, a charge of Rs. 500/- per day will be levied per head.
6. All boxers must possess their own Gum shield.
7. The Organizing Committee will provide boxing gloves, head guards and hand bandages to all boxers for all bouts.
8. Boxers who are already registered with IABF shall carry their Identity Card or should carry their original Municipality birth certificate along with mark sheet of Class 5th /8th /10th /Age verified by the School on their latter head in original for IABF registration purpose.
9. No teams will be allowed to participate unless Affiliation/Entry fees are paid to IABF.
10. Borrowing of boxers from any other unit is strictly prohibited.
11. Boxers who do not compete for any reason whatsoever will not be permitted free Lodging and will have to pay Rs. 500/- per head per day in advance to avail of these facilities.
12. The championship will be conducted as per IABF rules.

13. Persons accompanying the team as Manager and Coach will not be permitted to act as NTO's / R/J in the championship.
14. For the General Weigh-in, the Boxer's weight should not exceed the maximum of the Boxer's weight class nor be below the minimum of the Boxer's weight class which will also apply to the Daily Weigh-in.
15. All teams are requested to bring two flags (6 X 4) of their Association.
16. States/Boards who have achieved NO MEDAL during last three Sub- Junior Women National Boxing Championship will be permitted to field Six Boxers only.
17. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
