<b>Entry Fee</b>	:	For State & Boards Rs. 1000/- (payable to IABF only)
<b>Weight Class</b>	:	A team may consist of a maximum number of 10 boxers. No reserves are allowed.
<b>Eligibility</b>	:	Junior Boxers born in the year 1994 and 1995 only are eligible. Entry will be accepted on receipt of Entry by number & Entry by Name as per the enclosed format and duly signed by President/Secretary of the affiliated unit.
<b>Competition Format</b>	:	Junior 4 rounds of 2 minutes, 1 minute rest between rounds.
<b>Medical &amp; Weigh-in</b>	:	General weigh-in and medical examination of all boxers will be held at the venue from 0800-10.00 hrs. on September 24, 2012 and on subsequent days for those boxers who are drawn to Box from 0700 hrs to 0800 hrs..
<b>Draw</b>	:	Draw will be held immediately on completion of the medical & weigh-in on September 24, 2012.
<b>Team Participation</b>	:	The Participating team may bring the 1 Coach, 1 Manager and 1 R/J
<b>Boarding/Lodging</b>	:	Free lodging will be provided to all boxers and team officials by the organisers from September 23 – 29,2012.
<b>Arrival particulars</b>	:	The organizers will have their reception booth at Patiala Railway Station. All teams will duly be received on arrival at above Railway Stations upon receipt of prior intimation from the units to the Organizing Secretary only.

**Important:-**

1. Team officials, boxers and Ring officials are entitled to Railway Concession Orders which are enclosed.
2. The team/officials shall not arrive at venue earlier than the September 23 and shall leave by September 29, 2012.
3. Cost of travel of all participants and team officials up to Patiala will be borne by the respective units.
4. All boxers must possess their own Gum shield.
5. The Organizing Committee will provide boxing gloves, head guards and hand bandages to all boxers for all bouts.

6. No teams will be allowed to participate unless Affiliation/Entry fees are paid to IABF.
7. Boxers who do not compete for any reason whatsoever will not be permitted free boarding and Lodging and will have to pay Rs. 500/- per head per day in advance to avail of these facilities.
8. The championship will be conducted as per IABF rules.
9. Borrowing of boxers from any other unit is strictly prohibited unless the change of Units is Registered with IABF between April 01 and May 31 as finalized at the AGM at Hisar on March 16, 2008. However for the current year, Change of units/ transfer will be accepted if registered with IABF by September 14, 2012.
10. States/Boards who have achieved NO MEDAL during last three Youth Women National Boxing Championship will be permitted to field Six Boxers only.
11. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
12. For the General Weigh-in, the Boxer's weight should not exceed the maximum of the Boxer's weight class nor be below the minimum of the Boxer's weight class which will also apply to the Daily Weigh-in.
13. Boxers who are already registered with IABF shall carry their Indent Card otherwise they should carry their original Municipality birth certificate along with mark sheet of Class 5<sup>th</sup> /8<sup>th</sup> /10<sup>th</sup> /Age verified by the School on their letter head in original for IABF registration purpose.
