No entry will be accepted after 2<sup>nd</sup> January, 2019 under any circumstances.

- Entry Fee** : Rs. 1000/- (payable to NIBA)
- Weight Class** : A team may consist of a maximum number of 20 Men & 20 Women Boxers. No reserves are allowed.
- Team Eligibility** : J & K - 2 Team, HP- 2 Team, PUNJAB- 2 Team, CHD- 2 Team, HAR- 2 Team & Singh's Fight & Fit Association - 2 Team = Total 12 Team
- Boxer Eligibility** : Boxers between the age of 19 and 40 according to their year of birth (born between January 1<sup>st</sup>, 2001 and December 31<sup>st</sup>, 1979) are eligible to participate in the competition.
- Women Weight Categories** : 45 kg-48 kg, 51 kg, 54 kg, 57 kg, 60 kg, 64 kg, 69 kg, 75 kg, 81 kg, 81+ kg
- Men Weight Categories** : 46 kg - 49 kg, 52 kg, 56 kg, 60 kg, 64 kg, 69 kg, 75 kg, 81 kg, 91 kg, 91+ kg.



- Competition Format** : Three (3) rounds of 3 minutes, (one) 1 minute rest between rounds.
- Medical & Weigh-in** : General weigh-in and medical examination of all boxers will be held at the venue from 4 to 6 PM on 3<sup>rd</sup> January, 2019 and on subsequent days for those boxers who are drawn to Box.
- Draw** : Draw will be held immediately on completion of the medical & weigh-in on 3<sup>rd</sup> January, 2019.
- REFREE/JUDGE EXAM** : R/J Exam Following latest Rules' IABF will organize a R/J 1 Star Exam prior the competition in order for each participating State/UT/Board to have at least one certified R/J within its team at a reasonable cost. All State R/J are eligible to take this course. More information please contact Mr. Rahul Sharma, ROC Member, IABF Ph. 9813638915
- ARRIVAL PARTICULARS** : The Organizers will have their reception booth at Tohana Railway Station / Bus Stand. All team(s)/ official(s) will duly be received on arrival at Tohana Railway Station upon receipt of prior intimation from the State/UT/Board(s) to the Organizing Secretary.
- QUALIFICATION EVENT** : Best two Boxer per weight category qualify for Inter Zonal Men & Women National Boxing Championship at Chennai, Tamil Nadu from 24<sup>th</sup> to 27<sup>th</sup> February, 2019.
- BOARDING/LODGING** : All Team Delegations must pay Rs. 200/- (Two Hundred) their Boarding/ Lodging charges as above for the entire Championships Period (January 4 – 6) by January 3, 2019.
- Please note that accreditations for the Championships will be given only upon payment for accommodation.
- WEATHER** : The weather in Tohana in January is expected to be sunny with temperatures varying between 10-5°C.

#### **IMPORTANT**

1. The team/officials shall not arrive at venue earlier than the 3<sup>rd</sup> January and shall leave by 7<sup>th</sup> January, 2019
2. Cost of travel of all participants and team officials up to Tohana will be borne by the respective units.
3. The championship will be conducted as per IABF rules.
4. All boxers must possess their own Gum shield, Red & Blue Vest & Shorts according to their respective corner allocation.
