No entry will be accepted after 5<sup>th</sup> February, 2019 under any circumstances.

- Entry Fee** : Rs. 1500/- (payable to IABF)
- Weight Class** : A team may consist of a maximum number of 20 Boxers.  
No reserves are allowed.
- Boxer Eligibility** : Boxers between the age of 40 and 60 according to their year of birth are eligible to participate in the competition.
- Weight Categories** : 46 kg - 49 kg, 52 kg, 56 kg, 60 kg, 64 kg, 69 kg, 75 kg, 81 kg, 91 kg, 91+ kg.

- Competition Format** : Three (3) rounds of 90 seconds, 45 seconds rest between rounds.
- Medical & Weigh-in** : General weigh-in and medical examination of all boxers will be held at the venue from 8 to 10 AM on 14<sup>th</sup> February, 2019 and on subsequent days for those boxers who are drawn to Box.
- Draw** : Draw will be held immediately on completion of the medical & weigh-in on 14<sup>th</sup> February, 2019.

**Team officials** : 1-10 Boxer(s) – 1 Coach-cum-Manager  
10-20 Boxer(s) – 1 Coach & 1 Manager

One R/J will be allowed per team.

**Coaches** : Each Boxer will be entitled to be accompanied to the ring by up to three (3) coaches. However, only two (2) Coaches may mount the apron of the ring and only one (1) may enter the ring.

➤ All boxers must be accompanied by at least one IABF/AIBA certified coach (1, 2 or 3-Star) at ringside during the bouts.

➤ All Coaches allowed to work in the Field of Play (FOP) must be AIBA/IABF certified (1 to 3- Star).

➤ One of the 3 coaches can be replaced by an AIBA/IABF Certified Team Cutman.

➤ Any coach of State Level, who has not certified through AIBA/IABF, will not be allowed to access the FOP and must be registered as an Extra Official. d) Extra Officials Any individual who will be at the event in addition to the ones outlined in point 4.b., whom the

**EQUIPMENT** : Gloves, Head Guard & bandages will be provided by Organizing Committee – an IABF licensed supplier.

**FLAG PARADE** : During the opening ceremony, up to two athletes from each team must be present for the flag parade. All athletes have to wear the full track suit – pants and jacket. More information regarding the participant's meeting location and time will be provided by the Local Organizing Committee.

**COACH COURSES** : Coach Course Following latest AIBA Rules' IABF will organize a Coach Course prior the competition in order for each participating State/Board to have at least one certified Coach within its team at a reasonable cost. All NIS and National participation boxer Certificate are eligible to take this course.

**REFREE/JUDGE EXAM** : R/J Exam Following latest AIBA Rules' IABF will organize a R/J Exam prior the competition in order for each participating State/Board to have at least one certified R/J within its team at a reasonable cost. All State R/J are eligible to take this course.

**Arrival particulars** : The Organizers will have their reception booth at Durgapur Railway Station / Bus Stand. All team(s)/ official(s) will duly be received on arrival at Durgapur Railway Station upon receipt of prior intimation from the State/UT/Board(s) to the Organizing Secretary.

**Boarding/Lodging** : All Team Delegations must pay Rs. 200/- (Two Hundred) their boarding/ lodging charges as above for the entire Championships Period (February 14 – 17) by February 13, 2019.


Please note that accreditations for the Championships will be given only upon payment for accommodation.

**WEATHER** : The weather in Durgapur in February is expected to be sunny with temperatures varying between 30-15°C.

### **Important**

1. The team/officials shall not arrive at venue earlier than the 13<sup>th</sup> February and shall leave by 18<sup>th</sup> February, 2019
2. Cost of travel of all participants and team officials up to Durgapur will be borne by the respective units.
3. No teams will be allowed to participate unless Affiliation/Entry fees are paid to IABF.
4. The championship will be conducted as per AIBA rules.
5. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
6. All boxers must possess their own Gum shield, Cup Protector, Red & Blue Vest & Shorts according to their respective corner allocation.
7. No type of body piercing and body accessories is allowed to be worn during the bout.
8. Borrowing of boxers from any other unit is strictly prohibited
9. Person(s) accompanying the team as Coach and Manager will not be permitted to officiate in the championship.
10. All Boxers must have their Original Municipality birth Certificate, Certificate of Master Men State/Board Boxing Championship 2018-19 and School Certificate in which Father's Name, Mother's Name, Admission No., Admission years, Class and Date of birth.
