CASH PRIZE	:	Cash Prize each weight category:- Gold= 5000/- Silver= 3000/- Each Bout Looser = Rs. 1000/- Team Champion = Rs. 1,00,000/- (One Lakh) Best R/J = Rs. 5100/-

LOC will award prize money in each weight category (subject to a number of key factors):

An Athlete must win at least 1 (one) bout in order to be eligible to earn the designated prize.

In case if only one boxer is present in a weight category such athlete will not be eligible to receive a medal and prize money.

If an Athlete has a win by Walkover (WO) and is a medalist, such Athlete is entitled to receive a prize.

If an Athlete has a loss and no wins and is a medalist, such Athlete is not entitled to receive a prize.

BOXER AGE ELIGIBILITY: A Boxer between the age of 19 years and below the age 23 years according to their year of birth are eligible to participate in the competition. Boxers born from January 1, 2004 to December 31, 2007 will be eligible.

WEIGHT CATEGORIES : The U-23 Men following thirteen (13) Weight Categories will be contested:
Weight Category: 46-48kgs, 51kgs, 54kgs, 57kgs, 60kgs, 63.5kgs, 67kgs, 71kgs, 75kgs, 80kgs, 86kgs, 92kgs, +92kgs.

The U-23 Women following twelve (12) Weight Categories will be contested:

Weight Category: 45-48kgs, 50kgs, 52kgs, 54kgs, 57kgs, 60kgs, 63kgs, 66kgs, 70kgs, 75kgs, 81kgs, +81kgs

**DURATION AND
NUMBER OF ROUNDS;**

The U-23 Men's & Women's Competitions, the Bouts must consist of three (3) rounds of three (3) minutes each. (One) 1 minute break between rounds.

MEDICAL & WEIGH-IN

: General weigh-in and medical examination of boxers will be held at the venue from 8 to 9 AM

DRAW

: Draw will be held immediately on 15th March, 2026 completion of the registration.

COMPETITION REGISTRATION:

Boxer who are already registered with IABF shall carry their Record Book/Indent Card otherwise State/UT Boxer they should carry their original Municipality birth Certificate, Mark sheet OR School Certificate in which Father's Name, Mother's Name, Admission No., Admission years, Class and Date of birth.

Board Boxer they should carry their original Identity Card and Joining Letter.

In order to stop participation of borrowed Boxers in the championship, the boxers shall participate only from his/her birthplace; must provide Municipality Birth Certificate/Domicile certificate/ Ration Card/ Jamabandi Nakal last 4 and School certificate/10th Mark Sheet, if requested to do so;

No teams will be allowed to participate unless Affiliation/Entry fees are paid to IABF.

All boxers must possess their own Gum shield, Red & Blue Vest & Shorts according to their respective corner allocation.

No type of body piercing and body accessories is allowed to be worn during the bout.

Submission of the Medical Certificate: In all IABF-owned and IABF- sanctioned Competitions, a Boxer's IABF Medical Certificate issued within the previous 30 (thirty) days must be presented at the Sport Entries Check.

In all IABF-affiliated Competitions, a Boxer's IABF Medical Certificate issued within the previous one (1) year must be checked.

In order for a Medical Certificate to be valid, the examination must have been completed

- (i) by a NF ringside qualified Doctor, or NF registered medical Doctor
- (ii) no later than the period defined for submission of a medical certificate,
- (iii) the record of the examination must contain clear and legible results for all test areas, and

- (iv) has to be signed, and stamped on each page by the doctor after the doctor finishes performing a medical check on the Boxer.

A copy of the original laboratory documentation for Hepatitis B, Hepatitis C, and HIV tests must be done within 6 months, and must be presented together with the Medical Certificate.

Submission of the Fit-to-Box Form

In all competitions, a Fit-to-box Form signed by the boxer, must be submitted at the Sport Entries Check.

Submission of the Declaration of Non-Pregnancy

For women Boxers who are eighteen (18) years old or older, the Declaration of Non-pregnancy has to be signed by the Boxer.

For women Boxers who are under eighteen (18) years old, the Declaration of Non-pregnancy has to be signed by the Boxer and by at least one of her parents/legal guardians.

Cost of travel of all participants and team officials up to Venue will be borne by the respective units.

REFREE/JUDGE COURSE: IABF R/J Course Following latest Rules' IABF will organize a R/J Course prior the competition in order for each participating State/UT/Board to have at least one certified R/J within its team at a reasonable cost. BOARDING/LODGING : Free Boarding/Lodging will be provided to all boxers and team officials by the LOC.

SECURITY DEPOSIT Every team must have to deposit Rs. 5,000/- as security deposit for Accommodation and the same will be refunded after the event is over.

ANTI-DOPING AND MEDICAL RULES Competitions must adhere to the IABF Anti-Doping Rules and the IABF Medical Rules. In all IABF Competitions, anti-doping tests must be conducted

AWARDS : Boxers/ officials- Merit & participant certificate, Winner Cup, Medal & Cash Prize each weight category

EQUIPMENT : Gloves, bandages will be provided by Organizing Committee – an IABF licensed supplier

- Ten (10) oz gloves will be used for the Minimumweight category (46-48kg) to the Welterweight category (67kg). Twelve (12) oz gloves will be used from the Light Middleweight category (71kg) to Super Heavyweight category (92+kg).
